GENERAL INFORMATION

- This fee applies to internal services only. Fees for services delivered by contractors range from \$45-\$80 per hour for home support services, and from \$80-\$160 per hour for nursing care. Fees for equipment, gardening, home maintenance/modifications and other services not listed will be based on supplier rates or quotation. Fees are deducted from the Home Care Package fund. A cancellation charge at full cost will apply (for all service types) when less than 48 hours' notice of cancellation is given.
- Where staff use their own car on behalf of the client, \$1.45 per km plus GST will be charged.
- 24hr/7 days per week after hours support service is free of charge.

DESCRIPTION OF SERVICES

Home Care	Refers to household activities such as cleaning, dishwashing, clothes washing, ironing and shopping
Personal Care	Refers to assistance with self-care tasks such as showering, grooming, food preparation and assistance with mobility (e.g. getting in and out of bed).
Respite Care	Refers to care provided to a client to allow the usual carer to have a break from their caring responsibilities.
Nursing Services	Refers to professional healthcare provided by a Registered Nurse or an Enrolled Nurse.
